FEBRUARY 20, 2023 MINUTES

The Meeting of the Bristow City Council Meeting was called to order in the Council Chambers of the Municipal Building at 7:00 P.M. A roll call was had with the following members present. Reverend Cecil Washington opened with Prayer and then led the Pledge of Allegiance.

He stated the change in the Retirement Program was strictly for the employees, not him. At this time City Attorney Beth Anne explained to the Council about the Program that we have now. What we have now is that an employee is fully vested after 5 years. Once they quit, they can pull out their money in full or leave it in the Program, but cannot draw a monthly check until they are 65 years of age. This is unlike the Police & Fire that can draw their benefit after 20 years of service. We are wanting to change the plan to allow long term employees that have worked for the city to be able to retire at whatever age and draw their contribution monthly after 30 years of service and not wait till they reach the age of 65 years old.

There are a couple restaurants that have made interest in coming when the hotel gets started and we are very hopefully there will be more. He also stated "There are things going on and due to the Confidentiality clause, we are not at liberty to say anything at this time".

Discussion on Bristow Jones Airport Hangar leases. Airport manager Vicki Roth was not present, but City Attorney Beth Anne stated that everyone has turned in their lease agreement but 2. One has responded and the other one has not. We will start the proceedings in two weeks to start the removal process.

City Attorney's Report: Beth Anne introduced Sydney her new in-turn and stated that she has a lot of stuff going on.

Comments from Mayor and Council. Mayor Rick Pinson congratulate Council Member Kris Wyatt on winning the Mayoral Election. He stated that he is a firm believer that when one door closes, one will open and they have. He wanted to reassure Mrs. Wyatt, that if she needs anything, he is a phone call away. She stated she has his phone number". He also wanted her to know the employees are all here to help her. Again, he wanted to "Congratulate her on her win".
