

## City of Bristow

### MARCH 19, 2018 MINUTES

The regularly scheduled meeting of the Bristow City Council was called to order in the Council Chambers of the Municipal Building at 7:00 P.M. A roll call was had with the following members present. Mayor Leonard Washington. Council members: Judd Johns, Rick Pinson, Jeff Roberts, Tex Slyman, Edgar Spencer, and Randy Witty. Absent Councilman Kenny Odell and Jeff Willeford.

Reverend Dwayne Scaife opened with Prayer and then led the Pledge of Allegiance.

Motion was made by Pinson with a second by Johns approving Minutes of the March 5, 2018, Meeting. A roll call was had with the following members present voting as follows: Johns, Aye; Roberts, Abstain; Pinson, Aye; Slyman, Aye; Spencer, Aye and Witty, Aye. Motion passed.
