

City of Bristow

JUNE 1, 2020 MINUTES

The Meeting of the Bristow City Council Meeting was called to order in the Bristow Court House of the Municipal Building at 7:00 P.M. A roll call was had with the following members present. Mayor Rick Pinson, Councilman: Joe Church, Brandon Flood, Judd Johns, Jeff Roberts, Tex Slyman, Jeff Willeford and Kris Wyatt. Councilman absent: Randy Witty.

Councilman Kris Wyatt opened with Prayer and then led the Pledge of Allegiance.

Motion was made by Flood with a second by Roberts approving Minutes of the May 18, 2020, Meeting. A roll call was had with the following members present voting as follows: Church, Aye; Flood, Aye; Johns, Aye; Roberts, Aye; Slyman, Aye; Willeford, Aye and Wyatt, Aye. Motion passed.

Motion was made by Flood with a second by Roberts approving Minutes of the May 27, 2020, Special Meeting. A roll call was had with the following members present voting as follows: Church, Aye; Flood, Aye; Johns, Aye; Roberts, Aye; Slyman, Aye; Willeford, Aye and Wyatt, Aye. Motion passed.

Motion was made by Johns with a second by Church approving the Consent Agenda:

- e. Approval of Estimated Payroll Claims in the amount of \$72,705.09, for pay period ending June 12, 2020.

Johns stated that the splash pad that was put in at Kellyville cost about 35,000 to 50,000, maybe we could get their plans to see what all we would like to have in ours. Roberts suggested a splash pad be put in at the old Washington school property as well as a park.
