

### BRISTOW HOSPITAL AUTHORITY

Peter Juul with Carrus Lakeside Hospital gave an update to the Trustees. He stated that the HVAC should be done by July 7th, hopefully by the 21st of July everything should be complete, and the final inspection done. After the inspection is complete, it should take a couple weeks for the state to complete their paperwork.

Peter spoke on behalf of Oklahoma Gas & Electric, on the Energy Savings Program. He stated it was an excellent program. Carrus has done this at their other facilities. He stated that the Boiler system was ready for a museum, and with this plan they will replace the Boiler system. It would be no money up-front for the City.
