(Formerly Known as Bristow Medical Center); Authorizing Carrus Lakeside Hospital, Inc., to Move Forward With a Preliminary Analysis and an Investment Grade Audit as Recommended by the Feasibility Study; and Authorizing the Chairman to Move Forward with all Actions Necessary to Facilitate this Project.
