Update on operations and construction regarding Carrus Lakeside Hospital (formerly known as Bristow Medical Center), the Doctor's building adjacent to the hospital, and the Therapy Building, including usage by the community, and the status of approvals for a hospital license and a Medicare Provider Number.

Jordyn Case with Carrus Lakeside Hospital was present to talk to the Council about the opening of the Hospital. She stated that last time she was at the Council meeting, she announced that the hospital was going to open around the first of October. Since that meeting, they have found out that once they got the DEA Licenses, the company they order the Meds from said it will be October 26, 2023 before they can order and it will take a few days after that to get the meds. She stated that Carrus has tried everything they possible can to make this happen. She stated they will not open without the medication. She will have a definite opening date after they receive the meds.

Councilmember Joe Church asked about the Medicare number.

Jordyn stated that once they have 20 patients admitted into the hospital, they will be able to get the Medicare number.

Jordyn introduced the new Hospital Administrator. Her Name is Jill Atchley. Jill stated she has recently moved to bristow and loves the Community.
