- **B.** Building #2---St. George Church: Add 30-year architectural warranty; must have liability insurance; bonded; must complete in a set number of working days.
- C. Building #3---Depot Flat: Add per square foot replacement cost for rotted areas; must be commercially licenses; bonded; liability insurance; must complete in a set number of working days.
- **D.** Building #4---Medical Center (4th Street): Must have liability insurance; bonded; must complete in a set number of working days.
