
SEPTEMBER 5, 2023
MINUTES

The Meeting of the Bristow City Council Meeting was called to order in the Council Chambers of the Municipal Building at 7:00 P.M. A roll call was had with the following members present. Mayor Kris Wyatt, Councilmembers: Joe Church, Jeryn Fletcher, Frank Groom, Judd Johns, Tanya Langley, Brian Peters and Randy Witty. Councilmember Absent: Jeff Roberts.

Reverend Earnest Kellum with Prayer and then led the Pledge of Allegiance.

Presentation from Cody McGee with Watco and Blake Harvey with Stillwater Central Railroad on the Railroad crossings in town. Mr. McGee stated we could possibly get state or Federal Funding if we closed the crossing on West 2nd Street. The Railroad would be able to upgrade three (3) crossings in town. Councilman Joe Church asked why the Railroad does not maintain the crossings. Cody stated there are Several conditions they must comply with, and they do to an extent. The average life span on a crossing is eight to ten (8-10) years. Blake said a lot of the crossings are wood panel crossings, and they can only do One (1) crossing a year. Councilman Peters asked what they would replace them with. Cody said they would go back with Rubber. Cody stated if not funded by the state, they can only do one crossing at a time. Councilwoman Fletcher asked if we close 2nd street crossing will they replace Three (3) crossings from top to bottom. She was told yes, they would be replaced with gates, arms and crossing lights. The railroad was purchased in 2018 from BSFS. Mr. Mark Kennedy from the audience said that they would have to change the grade and fix streets to bring them up to grade. And on the heavy trafficked crossing, he would recommend using concrete instead of rubber or wood. Mayor asked if we close the street now can it be reopened later, she was told yes it could be. Cody said it would cost roughly \$458,000 a crossing and there needs to be a plan in place by November 1st.
